Show fees:

Baby, puppy, honorary and veteran	25 EUR
First dog	40 EUR
Second and another dog	30 EUR
Competition	15 EUR

Baby, Puppy, Honest and Veteran classes do not count as second and another dog.

The application after the deadline is increased by 10 EUR.

The show fee includes admission for one person. Accompaniment of the exhibitor is free. Absence from the show for reason is not a reason tu refund the show fees. The only exception is the reason for the due to epidemiological government measures.

Class:

- The division of the classes according to the CMKU (Czech-Moravian Cynological Union)
- To be included in the winners' class, a photocopy of the champion's diploma must be attached
- The age of the dog on the day of the show is decisive for inclusion in the class. Other condition must be on the day of application
- A separate application is required for each dog
- Each application must be accompanied by a copy of the Pedigree and copy of proof of payment
- Shifting dogs from class to is not possible on the day of show.

Veterinary conditions:

- 1. Dogs must be clinically healthy
- 2. Dogs originating from the Czech Republic must be accompanied by a valid vaccination card (according to § 6 of the Veterinary Act) or a valid passport for small animals. Dogs from EU member states and third countries must meet the conditions set out in Regulation 998/2003 of the European Parliament and of the Council of 26 May 2003.
- 3. Dogs which have not undergone a veterinary inspection within the prescribed time may not take part in the event.
- 4. Females hot, nursing and in the second half of pregnancy, aggressive individuals and individuals with surgical procedures to remove a defect in the dog's exterior are excluded from the show.

Individuals with cropped ears will not be admitted to the show grounds (see the Act on the Protection of Animals against Cruelty).

Documents for participation in the show

- entry form (received by the organizer no later than 7 days before the show)
- original certificate of origin (registration in the Pedigree is not obligatory) or confirmation that the Pedigree will be issued (only for the class of puppies and puppies)
- vaccination card with valid vaccination

General provisions:

The organizer of the show is not responsible for damages caused by the dog or the exhibitor, nor for the death of the animal or the loss of the dog. During the show, the owners will secure their dogs so that there is no mutual attack or possible injury to persons. Free running of dogs is not allowed! Biting dogs must be muzzled.

Changes to the dog's exterior made by varnishing, powdering, tinting the coat and basic treatment by trimming and tying the dogs on the tables are prohibited!

In the event that the show is not held for objective reasons, the show fees will be used to cover the costs associated with the preparation of the show.

Leading puppies and their sale at the show are prohibited!

The exhibitor agrees to state his address in the catalog. By completing and sending the application, the exhibitor agrees to the publication of photographs on the website or social networks.

By submitting the application, the exhibitor undertakes to abide by all the provisions of the CMKU Show Rules, these propositions and the instructions of the show organizers.

Protests:

Protest against the judge's decision is not allowed. Protests can only be made for formal reasons of violation of show regulations and propositions. The protest must be submitted in writing, only during the show, together with the deposit of CZK 1,000. If the protest is not accepted, the principal will be forfeited in favor of the eshow organizer.

Judge: Monika Petermayer: (change reserved)

Warning: the show is governed by the current government regulation against the spread of covid-19, valid for the Czech Republic.

In the case that the show will not be able to take place due to government anti-pandemic regulations, an alternative date will be proposed, or fees will be refunded to exhibitors who do not wish to show within the alternative date.
